(i.e. P.R.China, India, Mongolia and Vietnam)

1 July: All other Asian Countries

Applications will be considered on a "rolling basis" and admissions to the LL.M. International Finance program will be granted to successful applicants on a "first come first served" basis. Applicants will be informed within 6 weeks of receipt of the completed application. No application fee is required.

VISA/APS REQUIREMENTS

Students from the PRC, India, Mongolia and Vietnam must acquire APS (Akademische Prüfstelle) certificates before they can obtain student visas to study at the ILF. As APS certificates may take up to at least 3 months to be issued by the relevant authority, applications should be made early.

TUITION FEES: 20,000 EUR

This covers tuition, the use of the facilities of the ILF and Goethe University Frankfurt am Main, the conferment of the degree upon the successful completion of the program requirements, transcripts, degree certificates as well as selected extra-curricular activities. It does not cover the costs of living (i.e. board and lodging), health insurance, teaching materials or computer consumables. Students shall also bear the University's semester enrolment fees (currently about 350 EUR per semester) themselves.

SCHOLARSHIPS

Reduction of tuition fees by 3,000 Euro (15 % of tuition fees) if applications are received by the ILF by 15 January.

Reduction of tuition fees by 2,000 Euro (10 % of tuition fees) if applications are received by the ILF by 28 February.

CAREER OPPORTUNITIES

After graduating from the ILF, if you wish to stay and look for work in Germany, you can apply to extend your existing residence permit for up to 18 months (and work unrestricted). Such job seeker visas are granted as long as foreign students have evidence of receiving a degree from a German university, have health insurance and can support themselves financially during the period of stay.

C. Legal and Management Training Program

During the semester break between February and April, the Legal and Management Training Program will take place over a four-week period. Students will attend communication, presentation, interview and negotiation skills courses as well as specially-organized guest lectures and excursions to banks, law firms and institutions.

D. Master's Thesis

Students shall write a thesis within a 4-month period on a subject agreed in consultation with the student's thesis adviser.


